### A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE NORTHMONT SCHOOL DISTRICT FOR THE PROVISION OF A SCHOOL RESOURCE OFFICER(S) FOR THE 2015-2016 SCHOOL YEAR

**WHEREAS**, the Clayton Police Department and the Northmont School District have worked cooperatively together in years past for the provision of a School Resource Officer(s); and

**WHEREAS**, the Northmont School District has approached the City regarding provision of School Resource Officers for the 2015-2016 school year; and


**WHEREAS**, the Northmont School District has agreed to reimburse the City for additional costs associated with backfilling the assigned School Resource Officers' hours with part-time officers at a cost not to exceed \$79,300.00.

### NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLAYTON, STATE OF OHIO:

1. That the City Manager is authorized to enter into an Agreement in substantially similar form as the Agreement appended hereto with The Northmont School District for the provision of School Resource Officers for the 2015-2016 school year and including the provision that the City will be reimbursed by the Northmont School District for the backfilling of the assigned School Resource Officers' hours with part-time officers at a cost not to exceed \$79,300.00 per school year.

**AGREEMENT TO PROVIDE SUPPLEMENTAL PUBLIC SAFETY SERVICES**

This agreement is made on this 10<sup>TH</sup> day of AUGUST, 2015 by and between the City of Clayton, 6996 Taywood Road, Englewood, Ohio 45322 and the Northmont School District, 4001 Old Salem Road, Englewood, Ohio 45322 for the provision of City of Clayton, Ohio Police Department to provide School Resource Officers (SRO) to be assigned to Northmont High School and the Northmont Middle School for the 2015-2016 school year.

In consideration of the mutual covenants contained in this agreement, the Clayton Police Department and Northmont School District hereby agree as follows.

**Provision of School Resource Officer Assigned To the Northmont High School**

It is hereby agreed that two (2) Clayton Police Officers will be selected by the Clayton Police Chief and one (1) of them will be assigned to work up to forty (40) hours per week, for the high school and the second officer assigned to work up to forty (40) hours per week at the middle school during the school 2015-2016 school year.

Northmont School District hereby agrees to reimburse the Clayton Police Department for expenses incurred in covering the absence of the Full Time Officer ("i.e., "backfill staffing") with Part Time Officers at a Part Time Officer rate plus all direct labor expenses, and other projected cost not to exceed \$79,300 for the school year.

**Billing and Payment**

Actual officer hours worked will be calculated and billed on a quarterly basis for the provision of services rendered and described herein. Payment will be due within thirty (30) days of invoice.

**Cancellation Provisions**

It is further agreed that either party hereto may cancel this agreement upon 30 days written notice to the other party. Notices are to be sent, certified mail, return receipt requested, to the parties at the above listed addresses att: Chief of Police or School Superintendent, as applicable.

Should Northmont School District cancel this Agreement, it shall remain responsible for payment of any and all outstanding invoices for services rendered up to the effective date of termination.
