RESOLUTION NO. R -06-17-27

A RESOLUTION REQUESTING THE MONTGOMERY COUNTY AUDITOR, PURSUANT TO OHIO REVISED CODE SECTION 5705.03 (B)(1), CERTIFY TO THE CITY OF CLAYTON, OHIO THE TOTAL CURRENT TAX VALUATION OF THE CITY AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY A 3.50 MILL RENEWAL LEVY FOR A CONTINUOUS PERIOD FOR THE CLAYTON POLICE DEPARTMENT (R.C. 5705.19)

WHEREAS, Ohio Revised Code Section 5705.03 provides that when a taxing authority determines that it is necessary to levy a tax outside of the ten mill limitation for any purpose authorized by the Revised Code, prior to the certification to the Board of Elections of its legislation to submit the question of levying a tax outside of the ten mill limitation to the electors of the subdivision, the taxing authority shall certify a resolution to the county auditor requesting the county auditor certify to the taxing authority the total current tax valuation of the subdivision, and the dollar amount of revenue which would be generated by a specified number of mills; and

WHEREAS, the Council of the City of Clayton, Ohio finds it to be necessary, per R.C. 5705.19, to levy a tax in excess of the ten mill limitation for the benefit of the City of Clayton for the purpose of providing and maintaining motor vehicles, communications, other equipment, buildings, and sites for such buildings used directly in the operation of a police department, or the payment of salaries of permanent or part-time police, communications, or administrative personnel to operate the same, including the payment of any employer contributions required for such personnel under Section 145.48 or 742.33 of the Revised Code, at a rate not exceeding 3.50 mills for each one dollar of valuation which amounts to thirty five (\$.35) cents for each one hundred dollars of valuation for a continuing period commencing in tax year 2018, first due in calendar year 2019.


NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLAYTON, STATE OF OHIO:

1. That it is necessary, per 5705.19, to place a renewal tax levy for a continuous period in excess of the ten mill limitation for the benefit of the City of Clayton for the purpose of providing and maintaining motor vehicles, communications, other equipment, buildings, and sites for such buildings used directly in the operation of a police department, or the payment of salaries of permanent or part-time police, communications, or administrative personnel to operate the same, including the payment of any employer contributions required for such personnel under Section 145.48 or 742.33 of the Revised Code, at a rate not exceeding 3.50 mills for each one dollar of valuation which amounts to thirty five (\$.35) cents for each one hundred dollars of valuation for a continuing period commencing in tax year 2018, first due in calendar year 2019.

2. That the question of levying said taxes be submitted to the electors of the City of Clayton at the election to be held at the usual voting places within said City of Clayton on the 7th day of November, 2017.
3. That said levy be placed upon the tax list for collection for a continuing period commencing in tax year 2018, first due in calendar year 2019 if a majority of the electors voting thereon vote in favor thereof.
4. That all formal actions of City Council concerning and relating to the adoption of this Resolution were taken in open meeting of this Council.
5. That the Montgomery County Auditor is hereby requested, pursuant to R.C. 5705.03, to certify to the City of Clayton, Ohio the total current tax valuation of the City and the dollar amount of revenue that would be generated by the number of mills specified in Section 1 hereof, and the Clerk of Council is hereby directed to certify a copy of this Resolution to the Montgomery County Auditor upon its passage.


