RESOLUTION NO. R – 11 – 18 - 63

A RESOLUTION DESIGNATING POSTING LOCATIONS FOR ORDINANCES, RESOLUTIONS, AND SUMMARIES THEREOF IN ACCORDANCE WITH CHARTER SECTIONS 4.031 (E) AND (J)(1) AND 4.031 (G)(1)

WHEREAS, Clayton Charter Section 4.031(E) provides, “The ordinance summary shall describe the ordinance in brief and general terms and state that the ordinance is available for public inspection at the office of the Clerk of Council, together with a notation as to the time and place of its consideration for final adoption. *The posting of the summary shall be made in three places of public access as Council may designate* and shall occur at least three days prior to the date of the ordinance’s second reading; and

WHEREAS, Clayton Charter Section 4.031(J)(1) provides, “Every ordinance, in full or summary form, shall be published at least once within thirty days after its final passage or adoption. The ordinance in the form it was adopted shall be made available for public inspection in the office of the municipality. Publication shall be in a newspaper of general circulation in the City of Clayton. *A summary of every ordinance shall also be posted in three places of public access as designated by Council; and*

WHEREAS, Clayton Charter Section 4.032 (G)(1) provides, “Every resolution in full or summary form, shall be published at least once within thirty days after its final passage or adoption. The resolution in the form it was adopted shall be made available for public inspection in the office of the municipality. Publication shall be in newspaper of general circulation in the City of Clayton. *A summary of every resolution shall also be posted in three places of public access as designated by Council; and*

WHEREAS, City staff has advised the current three posting locations relative to Charter Sections 4.031 (E), (J)(1) and 4.032(G)(1) are: Fire Station 84, Fire Station 85, and the bulletin board located outside the Government Center; and

WHEREAS, City staff has advised the bulletin board located outside the Government Center has become deteriorated and staff therefore suggests Council designate Fire Station 84, Fire Station 85, and the City of Clayton website as posting locations in accordance with Charter Sections 4.031 (E), (J)(1) and 4.032(G)(1).

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLAYTON, STATE OF OHIO:






