# A RESOLUTION APPROVING INTERGOVERNMENTAL AGREEMENT WITH THE TROTWOOD FIRE DEPARTMENT FOR THE SALE OF NINE (9) PORTABLE RADIOS

**WHEREAS**, the Clayton Charter provides Council has the authority to exercise all powers of local self-government provided by to the City by the Constitution of the State of Ohio; and

**WHEREAS**, the Clayton Charter provides that the powers of Council are to be exercised in the manner prescribed in the Charter, and if not so prescribed in the Charter in the manner provided by ordinance or resolution of Council; and

**WHEREAS**, the Clayton Charter provides the powers of the City under the Charter shall be construed liberally in favor of the City; and

WHEREAS, a municipality may sell personal property not needed by it in such manner as prescribed by its charter and need not comply with R.C. 721.15 (ref. 1942 OAG No. 5558); and

WHEREAS, Clayton Charter Section 8.02(C)(3)(b) exempts intergovernmental contracts from competitive bidding; and

WHEREAS, the Clayton Fire Department would like to enter into an intergovernmental agreement with the Trotwood Fire Department for the sale of nine (9) portable radios for a total sale price of \$19,800.00, and the nine (9) portable radios are not needed for public use by the City of Clayton, are obsolete and/or unfit for the purpose for which they were acquired.

## NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLAYTON, STATE OF OHIO:

- 1. That the nine (9) portable radios referenced herein be sold by intergovernmental agreement to the Trotwood Fire Department for a total sale price of \$19,800.00 subject to receipt of an executed liability release substantially in the form appended hereto.
- 2. That this Resolution shall be effective as an exception to any ordinance, resolution or other legislation of the City of Clayton, Ohio, inconsistent with this Resolution or which imposes additional requirements for effectiveness or validity.

- 3. This Release is freely and voluntarily executed by RELEASOR after having been apprised of all relevant information and data and all other information relevant to such a Release.
