

# CITY OF CLAYTON, OHIO

## RESOLUTION NO. R - 06 - 19 – 47

### A RESOLUTION AUTHORIZING CERTAIN EMERGENCY EXPENDITURES

**WHEREAS**, the City of Clayton was severely impacted by the tornadoes which hit the Miami Valley area on Monday, May 27, 2019, causing substantial damages and extensive power outages; and

**WHEREAS**, on May 29, 2019, Council enacted Resolution No. R-05-19-42 ratifying the State of Emergency declared by the Mayor and City Manager on May 28, 2019; and

**WHEREAS**, a large portion of damage sustained by the City of Clayton included downed trees, damaged traffic signals, and power lines; and

**WHEREAS**, it was necessary for the City Manager to immediately address the damages and incur certain expenditures in so doing in order to preserve and protect the citizens and in furtherance of the safety and welfare of the City of Clayton and its citizens; and

**WHEREAS**, Clayton Codified Ordinance Section (and Ordinance No. O-02-16-03 enacted on March 3, 2016), authorize the City Manager to make and enter into contracts, purchases, and expenditures for the performance of work and labor for the City in an amount not to exceed \$25,000.00 and Charter Section 8.02(C)(1) and (C)(3)(a) (and Ordinance No. O-08-18-17 enacted on September 6, 2018) exempts from competitive bidding contracts not exceeding \$53,748.00 and further exempts from competitive bidding emergency contracts or expenditures authorized by a two-thirds vote of the members of Council.

### **NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CLAYTON, STATE OF OHIO:**

1. The following emergency expenditures incurred and relating to repairing damages sustained by the City as a result of the tornadoes which hit the Miami Valley area on Monday, May 27, 2019 are hereby retroactively authorized and approved:

*Traffic Signal Repairs in an amount not to exceed \$25,068.00; and  
Tree Removal Expenses in an amount not to exceed \$30,000.00.*

2. That this Resolution shall be effective as an exception to any ordinance, resolution or other legislation of the City of Clayton, Ohio, inconsistent with this Ordinance or which imposes additional requirements for effectiveness or validity.
