# Minutes of January 7, 2021 Council

Regular Meeting of the Clayton, Ohio City Council Clayton Government Center January 7, 2021

Due to the Governor's orders on limited size of meetings for COVID-19, Clayton's City Council conducted this meeting on Thursday January 7, 2021 via the Zoom meeting format

#### CALL TO ORDER

The meeting was called to order by Mayor Stevens at 7:30 PM. Present were Mayor Stevens and Councilmembers Bachman, Henning, Merkle, Kelly, and Lieberman. Motion by Kelly to excuse Gorman who is out this evening, motion second by Henning. All yeas, motion passed.

### **CLERK'S REPORT**

Clerk Seim presented the minutes of the December 17, 2020 Council workshop. Motion by Bachman, second by Kelly to approve the minutes as presented. All yeas, motion carried.

## **NEW BUSINESS**

Lieberman made a motion to Table Resolutions R-01-21-01 and R-01-21-02 until after an Executive Session later this evening. Motion was second by Kelly. All yeas, motion carried.

Resolution No. R - 01 - 21 - 03 A Resolution Authorizing the City Manager to Accept Bid and Enter Into an Agreement with Security Fence Group, Inc. for the 2021 Union/Salem Intersection Safety Project (PID 112158) in an Amount Not to Exceed \$65,000. Randy Sanders, Public Service Director, advised Security Fence Group Inc. was selected for the 2021 Union/Salem Safety Project after competitive bids were received. The city was awarded grant funding from the state to improve the safety at the intersection, with the project being fully funded by a safety grant through ODOT which will include new mast arms and signals and widening/extension of the southbound Union Road right turn lane. The only cost to the city is the decorative addition to the mast arms, luminaire, signal supports and pedestrian crossings. This will be the same decorative addition to the Westbrook intersection schedule for 2022. Motion by Merkle to approve the Resolution, second by Lieberman. All yeas, motion carried.

Resolution No. R - 01 - 21 - 04 A Resolution to Appoint Clayton Representatives to the First Suburbs Consortium for the Year 2021. Motion by Lieberman to appoint Gorman and Henning and Merkle as an alternate, motion was second by Bachman. All yeas, motion carried.

Resolution No. R - 01 - 21 - 05 A Resolution Approving Appointment of Two Members to the Volunteer Peace Officer's Dependents Fund Board for the Year 2021. Motion by Henning to appoint Lieberman and Kelly, motion was second by Merkle. All yeas, motion carried.

Resolution No. R - 01 - 21 - 06 A Resolution Appointing Clayton Representatives to the Volunteer Fire Fighter's Dependents Fund Board for the Year 2021. Motion by Henning to appoint Lieberman and Kelly, motion was second by Bachman. All yeas, motion carried.

Resolution No. R - 01 - 21 - 07 A Resolution to Appoint a Clayton Representative and an Alternate to the Miami Valley Regional Planning Commission and Transportation Committee for the Year 2021. Motion by Henning to appoint Gorman and Stevens as the alternate, motion second by Kelly. All yeas, motion carried.

Resolution No. R-01-21-08 A Resolution Appointing Member to the Cost Recovery/Impact Fee Appeals Board. Motion by Merkle to appoint Bachman, motion second by Henning. All yeas, motion carried.

Resolution No. R-01-21-09 A Resolution Approving a Wage Agreement for the Year 2021 with the International Association of Firefighters (IAFF) Local 4379 for Firefighters within the Clayton Fire Department. Elaine Wittman, Assistant to the City Manager/Human Resources advised the current firefighter's contract includes a wage reopener for 2021. Members of the bargaining unit and city staff discussed and agreed upon a 2.0% cost of living (COL) increase effective January 11, 2021. All other provisions of the Collective Bargaining Agreement will remain in full force. The current contract expires March 31, 2022. Motion by Kelly to approve the Resolution, second by Lieberman. All yeas, motion carried.
