## **EXHIBIT A TO RESOLUTION NO. R-06-25-47**

### 7. Motions to Reconsider:

#### **Timing Of Motion To Reconsider:**

Motions to reconsider an approved item **of legislation** must be made before adjournment of that session of Council for those items of legislation that are effective immediately (see III.B of these Rules); ~~m~~Motions to reconsider other legislation must be made prior to the close of the next following regular meeting of Council.

#### **Who Can Make A Motion To Reconsider:**

A motion to reconsider may be made only by a member of the prevailing side. ~~A motion to reconsider, being laid on the table, may be taken up and acted upon at any time when the Council is engaged in the transaction of other business.~~

#### **Number Of Motions To Reconsider:**

No motion to reconsider may be made more than once on any ~~matter~~ **item of legislation** and the same number of votes is required to reconsider the action of Council as was required to pass or adopt the ~~matter~~ **item of legislation**.

#### **Timing of the Reconsidered Item:**

**If the Motion to Reconsider is approved, then the item of legislation to be reconsidered will be presented to Council for reconsideration at the next regular meeting of Council and listed on the Council agenda under "Old Business".**
